Dear Valued Customer:

Starting July 1, 2021, CR&R Environmental Services, together with the County of Orange will launch an expanded waste, recycling, and organics collection program.

New program offerings include bulky item collection totaling three (3) collections per year (up to four (4) items per collection) per unit, an annual paper and document shredding event, a compost giveaway, and an annual neighborhood cleanup. In addition, certain existing programs are maintained, including, holiday Christmas tree collections, and free recycling education and assistance.

Also included in your multifamily program is free technical assistance and staff training for recycling programs, free print materials and signage for your location, tenant memos, and waste reduction education and support. Free recycling collection services will also be provided.

Below is relevant information for you regarding this change:

- Rate: New rates will become effective July 1, 2021. See following pages for further information.
- Service Day: Your service day(s) will remain the same. For any requested change in service levels, please contact our Customer Service Department.
- Billing: Multifamily customers will continue to be billed monthly with CR&R's first bill going out on July 1, 2021.
- Equipment: Ware Disposal will conclude service and remove their equipment on June 30th, 2021. New bins in the same size and service frequency will be delivered between June 30th and July 1st, 2021.

Business Recycling – California State Law

Assembly Bill 341

This law requires California commercial businesses and public entities that generate four (4) or more cubic yards of waste per week and multifamily housing complexes with five (5) or more units, to adopt recycling practices.

Assembly Bill 1826

Requires businesses that generate two (2) or more yards of municipal solid waste (recycling, organics, and landfill) per week to arrange for organic recycling services.

Senate Bill 1383

Establishes methane emissions reduction targets in a statewide effort. In accordance with this law, all local jurisdictions must provide organic waste collection services to all residential and commercial generators by January 1, 2022, and to direct this material from landfills. Organic waste includes food scraps and green waste such as landscape and pruning waste.

Assembly Bill 827

Requires businesses serving food and beverages without formal wait staff to make composting and recycling bins accessible to customers and clearly marked with educational signage indicating what is accepted in the local solid waste programs.
