CR&R Services

To support City and State recycling goals, CR&R offers the following services for effective on-site sorting for your project needs with the goal of reducing the volume of landfill-bound debris. Containers are available on a temporary basis for the duration of the project.

Most Common Container Sizes:

Temporary 3-Yard Bin

Suitable for smaller projects generating lighter weight debris such as general construction material or clean up.

10-Yard Rolloff

Suitable for heavy C&D debris such as concrete, asphalt, and dirt.

40-Yard Rolloff

Suitable for general C&D debris such as wood, drywall, metal, mixed C&D materials.

C&D Materials Collected:

- Mixed C&D
- Asphalt
- Concrete
- Bricks, Masonry, Stone
- Cardboard / Paper products
- Dirt / Soil – Clean Fill
- Rock/Sand/Gravel
- Stucco/Plaster (clean, no debris)
- Drywall (clean)
- Wood and Wood pallets
- Carpet / Padding
- Scrap Metal
- Appliances (separated)



All temporary CR&R C&D services have a 7-day rental period, with a maximum of 14 days.

RECYCLABLES

Source separated recycling & pure load types
(according to materials):

- Asphalt
- Concrete
- Dirt

NO Serpentine or Asbestos-contaminated soils



- Cardboard
- Paper
- Plastic
- Metal

No Flexible Plastics



- Green waste (e.g., leaves, weeds)
- Wood
- NO Palm Fronds



LANDFILL

Materials that cannot be recovered
during mixed-waste processing:

- Broken Glass
- Ceramic tiles
- Food wrappers
- Non-numbered Plastics
- Mixed Products
(i.e., Plastic/ Metal combination)
- Palm Fronds
- Flexible Plastics
- Polystyrene
- Mirrors

- Fiberglass
- Fluorescent light tubes
- Asbestos or lead-coated materials
